# What is a grassroots movement?

grassroots movement is one that uses the people in a given district, region or community as the basis for a political or economic movement. Grassroots movements and organizations use collective action from the local level to implement change at the local, regional, national or international levels.

The Montana Grassroots Action Network currently is comprised of about 1,700 co-op member-owners from across the state, and all 25 member electric cooperatives. The network members are sent updates once each month on the state and federal public policy challenges facing our electric co-ops. From time to time, these updates may ask our grassroots folks to contact elected officials to support or oppose proposed legislation or regulations.

funding and how we are able to assist our local community with more than \$72,000 of funding for Low Income Energy Assistance and LED lighting projects, and appliance rebates. General Manager Tye Williams introduced Southeast Electric employees and updated members on the new Transmission line going in at Mill Iron. He also stated that we will continue to be aggressive with our pole-testing program and have applied for a grant to help increase the number of poles replaced each year. Tye mentioned rate changes for 2025 due to increases in cost of purchased power, costs of supplies and competitive wages.

#### **Speakers**

Special speakers included Gary Wiens of the Montana Electric Cooperatives' Association and Jeremy Mahowald of Upper Missouri Power Cooperative. Gary shared news on the legislative front and the battles that cooperatives are fighting to ensure we have reliable energy. Gary encouraged everyone to contact their legislators, congressmen, senators, etc. He reported that he had 41 members sign up for MECA's Grassroots Action Team.

Jeremy Mahowald, general manager of Upper Missouri Power, also talked about the challenges it is facing from internal disunity, new regulations and exponential growth in the Bakken. He stated that in this era of rising costs and extreme growth, Upper Missouri is doing its utmost to provide low-cost power and a reliable power supply. It is working with Basin Electric Power Cooperative to build transmission networks and new gas, wind and solar power generation facilities to serve the farms, ranches, oil wells, gas production and new industrial loads that are coming its way.

Gary and Jeremy encouraged all members to actively participate in their cooperative, and to keep fighting for what they have here in rural southeastern Montana.

Downed power lines can be *deadly*. Always assume a downed power line is *live* and avoid approaching them or anything near them.

#### **Use Precaution**



Downed power lines can energize the ground up to 35 feet away. Even more in wet conditions.

Never drive over downed power lines or anything in contact with them.



If you see a downed power line, call 911.



Never try to move a downed power line.

If a vehicle contacts a power line or utility pole...

#### STAY AWAY AND CALL 911



Consider all lines to be live and dangerous.



Warn others to stay at least 35 feet away.



Stay in place or inside your vehicle unless you see fire or smoke.



**Tell others** not to approach vehicle, downed lines or anything that may be in contact with downed lines.



Call **911**.

### In the Event of Fire or Smoke

Do not touch the ground and vehicle at the same time.



Jump from the vehicle with your feet together.
