RATE INCREASE COMING IN JANUARY 2025

The possibility of raising rates during our annual meeting and in different *Rural*




Montana articles for the last couple of years. Over the past few years, all of us have dealt with a compounded inflation growth of 21 percent since 2020.

At Southeast Electric Cooperative, on average, we are paying 50 percent more now for materials than we did in 2020. As I mentioned at the 2024 Annual Meeting, keeping qualified staff in this tight labor market has been difficult. We have been able to keep rates steady during this time, as we have seen a 35-percent increase in kilowatt hour (kWh) sales since the end of 2020.

However, Western Area Power Association (WAPA) power, the electricity we get from the dams on the Missouri System, will increase 9 percent in January 2025, and 7 percent in January 2026. Our other supplier, Basin Electric Power Cooperative, will raise its rates by 7 percent in January 2025, with another rate increase planned for 2026. As we are forecasting continued growth in kWh sales for 2025, we do not need to match the rate increases of

our suppliers, and will be implementing an overall 2 percent rate increase on January 1.

The base charge for the residential and small commercial rates will increase by \$2. The large industrial demand charge will increase, and the heat rate will increase from \$0.060 per kWh to \$0.063 per kWh. These changes will not affect every bill by 2 percent, as this is an average increase for our entire system. Get your applications in, scholarship deadlines fast approaching

Southeast Electric Cooperative encourages students and members to continue learning. Scholarship funds are a good way to help with this goal. Since 2009, Southeast Electric has awarded over \$70,000 worth of scholarships. We consider it an investment in the future of our cooperative.

2025 scholarship applications are due to Southeast Electric by 5 p.m. on January 24. The applicant or parents/guardian must be a member of Southeast Electric Cooperative, Inc. Students whose parents are part of a corporation that is a member of Southeast Electric may also apply.

Basin Electric Power Cooperative Scholarship: Each year, Basin Electric Power Cooperative awards one \$1,000 scholarship to a student of a member consumer. The scholarship can be used to assist in paying for the costs of the student's college education. Applications must be sent to Southeast Electric Cooperative.
