#### Annual Meeting: Bylaw amendments

The annual meeting is coming up quickly and will be held on June 13th at the Southeast Electric truck shop in Ekalaka. In addition to the regular meeting agenda, the board will present a resolution to amend the bylaws to the membership. There are minor wording adjustments, but the primary goal is to simplify the directorship nomination process and streamline annual meeting timelines for office staff.

• Article III. Section 1. Amendments are designed to give staff more time to plan, including speakers, food and entertainment. The current bylaws indicate that the board must decide the annual meeting date at the February



meeting. The updated language allows the board to designate the annual meeting date at any meeting, provided it is selected by the end of February. • Article IV. Section

**3.** Amendments clarify qualifications for trustees. The significant change allows authorized agents of member companies to serve as trustees, provided they are bona fide residents and physically reside in the district for which they are running. Another change clarifies that employees cannot be trustees, and must wait three years after employment ends to run for a trustee position.

• Article IV. Section 4. Amend-

ments in this section simplify the process for nominating trustees. This removes the nomination committee and nominations from the floor at the annual meeting. The only way to be nominated for a trustee position will be by petition, starting in 2026. Additionally, the petitions will have designated dates for signing and returning them to the office of Southeast Electric. This designated timeline will allow office staff to prepare and mail out required documents to the membership for each annual meeting.

We will be mailing out the amendments to the bylaws with the annual meeting notice; however, please get in touch with us if you would like to learn more about the planned changes before then.
